Council members opted this year for a freeze on tax rates.

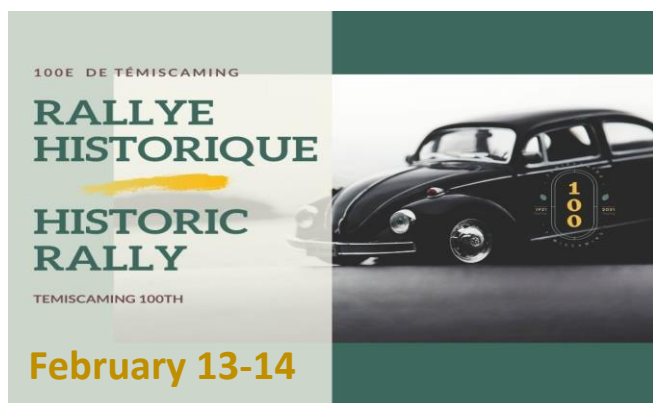
Payments are due on March 31, July 31 and October 31, 2021. If you are having difficulty making your payments on the required dates, please contact the accounting department to make a payment agreement.
